Application Program Interfaces: What You Need to Know About Your Data

What is an application program interface (API)? According to Wikipedia, an API is "a set of routine definitions, protocols and tools for building software and applications." In the case of transit, distinct systems such as scheduling, automatic vehicle locating, electronic fare collection, computer-aided dispatch, automatic passenger counting, ticket vending machines and maintenance management systems use APIs to exchange information.

First, APIs are not complicated. These simple programs are used to exchange information between

systems or to communicate between servers and browsers. For example, an electronic fare collection system needs APIs for selling fare products and real-time validation as passenger boardings. APIs are typically based on XML or JSON. Both of these data transfer formats are easy for humans to read and write and easy for machines to parse and generate. In fact, code for parsing and generating XML and JSON data is readily available in many programming languages.

Second, APIs should not be expensive. These are simple programs, not complicated beasts. Unless you have asked for changes, maintenance is not required except for the occasional system update. It's your data; you have the right to share it and there should be no usage fees.

Third, APIs may be proprietary because the provider of the API is taking information from their (your) database and making it available to third parties. By nature, an API is a custom protocol that allow different systems to communicate with each other. However, the API is what makes a proprietary system

A transit agency should not include language in an RFP similar to: "No proprietary or custom designed protocols shall be used." Instead, you should include language that "proprietary APIs and custom-designed protocols shall be openly published, documented and based upon a standard protocol, such as XML or

Fourth, you have a right to your data. Be aware that your system suppliers may use APIs as leverage. The holder of the API has the ability to set the price, control access and limit your options. You purchased the system and you have a right to your data.

APIs are critical to your success and keeping control is a step toward increased flexibility down the road. APIs provide an open architecture that supports vendor independence and streamlines integration. Choice creates competition and competition serves you and your riders.

Try to avoid putting your agency in a position of being stuck with a particular vendor. Make sure a level playing field is established from the start by requiring open APIs with their interface control document (ICD). If you feel you do not have the choice of going to another vendor, negotiate directly with your current vendor. Buy direct, and keep control of the information you have already payed for, eliminating other markups and usage fees. Enjoy the freedom of working with the best solution provider for you.

Fifth, open standards are available thanks to the efforts of Google and the SIRI initiative, GTFS-realtime supports trip updates, service alerts and vehicle location in real time, allowing updates to users that enhance their experience of your transit services.
